## HATTERAS INVESTMENT PARTNERS PRIVACY POLICY

In recognition of Hatteras' fiduciary obligations and desire to maintain its high ethical standards to its Investors, Hatteras has adopted this Privacy Policy in adherence to SEC Regulation S-P, 17 CFR 248.30 for Hatteras Investment Partners, LP ("Hatteras") and the Hatteras Funds (collectively referred to as the "Fund(s)") to safeguard the personal information of its consumers and customers.

<b>FACTS</b>	<b>WHAT DOES HATTERAS INVESTMENT PARTNERS DO WITH YOUR PERSONAL INFORMATION?</b>
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The type of personal information we collect and share depends on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"><li>• Social Security Number</li><li>• Account balances</li><li>• Account transactions</li><li>• Transaction history</li><li>• Bank Account/Wiring Instructions</li><li>• Checking account information</li></ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in our Privacy Notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Hatteras Investment Partners chooses to share; and whether you can limit this sharing.

<b>How does Hatteras Investment Partners protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
<b>How does Hatteras Investment Partners collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"><li>▪ open an account</li><li>▪ provide account information</li><li>▪ give us your contact information</li><li>▪ make a wire transfer</li><li>▪ tell us where to send or wire the money</li></ul>

<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"><li>▪ sharing for affiliates' everyday business purposes – information about your creditworthiness</li><li>▪ affiliates from using your information to market to you</li><li>▪ sharing for non-affiliates to market to you</li></ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

<b>Affiliates</b>	<p>Companies related by common ownership or control.
